

# Municipal District of Bonnyville No. 87 Action Request

Title:	M.D. Lands Inventory Report Recommendation - Muriel Lake	

## **PROPOSAL**

Administration conducted an internal review of all lands titled to the M.D. of Bonnyville No. 87 (M.D.) and presented Council with these results at a workshop on September 29, 2022. From those discussions, Administration is recommending. From those discussions, three (3) vacant undeveloped lots were identified on the south side of Muriel Lake for further consideration by Council.

## DISCUSSION

During the internal review process, Administration was able to determine that when subdivision plan 782 0510 was originally registered in 1978, the area was designated as reserve lands. The reserve designation was removed in 1983 and the lot was further subdivided into six (6) parcels (Plan 832 1514) and portions of Birch and Bear Road were extended to access the newly created lots, as shown in Appendix B.

The three parcels on the south side of Muriel Lake within SE-21-59-5-W4M that Administration is recommending be offered for purchase through public auction are as follows:

It was determined that the M.D. has no projected or current use for these parcels; therefore, these lands can become available for public sale as per Part 3, Section 70 of the *Municipal Government Act* and M.D. Policy 2A.009, the M.D.'s Municipal Lands Policy as shown in Appendix C.

The estimated market value for the subject lands is shown in the table above. As per Section 4 of Policy 2A.009, the M.D.'s Municipal Lands Policy, the lands can be sold by Public Auction if approved by Council with each parcel being subject to a reserve bid equal to 80% of the estimated market value.
