# Title: To Support Ukrainian Refugee Families Displaced by the Russian Invasion of Ukraine

WHEREAS: Many Ukrainian families have been displaced by the war;

AND WHEREAS: These displaced families have become refugees and in many cases have immigrated to Canada with no belongings;

AND WHEREAS: We have a vibrant and long standing Ukrainian community locally that would be a good cultural fit for these displaced families;

AND WHEREAS: The M.D. of Bonnyville has the resources to assist some of these families with their relocation to Alberta.

NOW THEREFORE BE IT RESOLVED THAT: Administration be directed to research opportunities for support to bring refugee Ukrainian families to the M.D. of Bonnyville and bring a report back to Council by April 1, 2023 with options for support implementation, and furthermore that Council approves the allocation of \$30,000 annually for a Council approved support program until the crisis in Ukraine has ceased.
