PROPOSAL & BACKGROUND

On February 14, 2023 Council approved changing the starting time for Regular Meetings of Council and Committee of the Whole Meetings from 9:00 AM to 1:00 PM as soon as possible. Administration has prepared this report to bring forward the process for this change and a proposed effective date for Council's consideration.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

At the October 26, 2022 Organizational Meeting, Council approved scheduling all Regular Council and Committee of the Whole Meetings for 2023 to start at 9:00 AM. On February 14, 2023 Council approved changing this start time to 1:00 PM.

Taking into consideration that agenda items such as Public Hearings and Delegations have already been scheduled for February 28 and March 14, 2023 with a meeting start time of 9:00 AM, Administration is proposing for the new start time of 1:00 PM to be effective for the March 28, 2023 Regular Meeting of Council.

Additionally, Section 193(3) of the *Municipal Government Act* requires notice to be provided to the public of any changes to regularly scheduled meetings. This change will be advertised in accordance with the M.D. Public Notifications Bylaw.

Furthermore, Administration is requesting direction on whether Council would like to also change the start time of the 2023 Organizational Meeting, or keep it as it is currently scheduled. This meeting is currently scheduled for October 24, 2023, starting at 9:00 AM.
