# PROPOSAL & BACKGROUND

In December 2022 Administration sent out letters to the Town of Bonnyville, City of Cold Lake and Village of Glendon proposing the formation of a Regional Sports Tourism Committee and inviting them to participate in this new initiative.

# **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

Administration received a response from all three municipalities confirming their interest in participating in this initiative with the M.D. of Bonnyville. Additionally, the City of Cold Lake and Village of Glendon have confirmed their Council appointments to the Committee.

Before Administration can proceed with scheduling an initial start-up meeting, Council needs to approve appointment to this Committee. The City of Cold Lake and Village of Glendon have both appointed their Mayor.

Administration would recommend this initial appointment be until October 2023. Once a formal Terms of Reference is approved outlining the permissible duration and frequency for an appointment, Council can approve an appointment in line with these terms at the 2023 Organizational Meeting.
