#### **PROPOSAL & BACKGROUND**

Administration has prepared a new policy to allow for the use of electronic signatures by the municipality for Council's consideration.

## **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

The use of electronic signatures is becoming increasingly common as a way to improve efficiency in organizational operations and reduce the amount of time necessary to obtain required signatures for correspondence and documentation. Additionally, in light of the recent COVID-19 Pandemic, the use of electronic signatures can help ensure business continuity in the event of an emergency or disruption to operations.

Section 213(5) of the *Alberta Municipal Government Act* allows for the reproduction of signatures, including the use of electronic signatures, if authorized by Council.

The Committee of the Whole reviewed this new policy on April 18, 2023 and are recommending that Council adopt the policy as presented.


