APPENDIX A BYLAW NO. 1846

A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87, IN THE PROVINCE OF ALBERTA TO IMPOSE PENALTIES ON UNPAID TAXES HEREBY CITED AS THE UNPAID TAX PENALTY BYLAW.

WHEREAS, under the provisions of the Municipal Government Act, R.S.A 2000, Chapter M-26, and amendments thereto, a Council's power to pass a bylaw includes a power to amend or repeal a bylaw;

AND WHEREAS, under the provisions of the Municipal Government Act, R.S.A 2000, Chapter M-26, and amendments thereto, a Council's power to pass a bylaw to impose penalties for non-payment of property taxes in the current year and for non-payment of property taxes in other years;

AND WHEREAS, the Council of the Municipal District of Bonnyville No. 87 deems it to be in the public interest to define terms of payment and impose penalties for non-payment of property taxes;

NOW THEREFORE, the Council of the Municipal District of Bonnyville No. 87, duly assembled in the Province of Alberta, hereby enacts the following:

1 PENALTIES

- 1.1 That a penalty of 12 percent be applied to all current taxes remaining unpaid after the 15th day of September or 30 days after the tax notice is sent, whichever date is later, in any year.
- 1.2 That the penalty shall be added on the 16th day of September or 31 days after a tax notice has been sent, whichever date is later.
- 1.3 That the said penalty, when applied, shall form part of the current unpaid taxes.
- 1.4 That any taxes remaining unpaid after the 31st day of December of the year for which they are levied, there shall be added there to by way of penalty, an amount of 10 percent in the next succeeding year so long as the taxes remain unpaid.
- 1.5 That the said penalty shall be applied to the unpaid taxes as of the 1st day of March of the succeeding year and shall be added thereto on that day.
- 1.6 That the said penalty, when applied, shall form part of the unpaid taxes.
- 1.7 That nothing in this bylaw shall be construed to extend the time for payment of taxes nor in any way to impair the right of distress or any other remedy provided by the Municipal Government Act for the collection of taxes.

2 REPEAL

2.1 That upon third reading of Bylaw No. 1846, Bylaw No. 1746 and all amendments thereto are hereby repealed.

3 SEVERABILITY

3.1 It is the intention of Council that each separate provision of this Bylaw shall be deemed independent of all other provisions herein and it is the further intention of Council that if any provision of this Bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion shall be severed and the remainder of the Bylaw is deemed valid and enforceable.

4 EFFECTIVE DATE
