Title: Bylaw No. 1845 Amending Local Improvement Tax Bylaw

#### **PROPOSAL & BACKGROUND**

Whereas Bylaw No. 1253 imposes a local improvement tax for existing properties subject to the connection to the Hamlets of Ardmore and Fort Kent water systems, Bylaw 1708 defines the tax amount and properties subject to the local improvement tax, and section 402(1) of the Municipal Government Act identifies that a council must revise the bylaw where an existing property, subject to the local improvement, has been subdivided or consolidated.

# <u>DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS</u>

The following properties were consolidated as follows;

Plan 2107EO Block 2 Lot 4 (Roll 6105251021) consolidated with Lot 3 (Roll 6105251020) Plan 99HW Block 2 Lot 15 (Roll 6204012022) consolidated with Lot 14 (Roll 6204012021)

The new local improvement levy for 2023 will be \$274.48. The 2022 local improvement levy was \$273.61.
