

Municipal Development Plan (MDP)

Public engagement was conducted for the MDP in February of 2023 with Open Houses at Eastbourne, La Corey, and Cherry Grove. We also completed a successful online survey that received 330 responses. Administration is currently working with the consultant, Urban Systems Ltd., to create a draft document taking into consideration the feedback we received from the public.

Intermunicipal Development Plan (IDP)

The IDP, Bylaw No. 1832, with the City of Cold Lake officially replaced the previous IDP on April 11, 2023 when the City of Cold Lake Council passed 3rd reading. The M.D. had previously approved 2nd and 3rd readings for the IDP on March 28, 2023.

Moose Lake and Highway 55 Area Structure Plans (ASPs)

As part of a 3 year consulting contract with Urban Systems Ltd, the initial stages of research for the Highway 55 and Moose Lake ASP reviews are underway. Public Consultation for the ASP will be scheduled this summer.
