## PROPOSAL & BACKGROUND

Administration is presenting Policy No. 2A.002 Expenditures not Included in Budget Policy to be rescinded.

During the January 24, 2023, Council Meeting, Council had discussion pertaining to the existing Procurement Policy regarding the current need to bring procurement recommendations back to Council where they had already been approved in the Operating Budget and the Capital Plan for the year.

In the interests of efficiency, Policy No. 2B.012 Procurement Policy Amendment was adopted by Council at the May 9, 2023, Regular Meeting of Council, removing the requirement to bring expenditures not included in an operating or capital budget to Council for approval, and placing the responsibility with the CAO as per Bylaw 1329.

The amended policy removes all procedural elements from the existing policy and provides the principles of action for procurement within the municipality. This is consistent with industry best practice relating to policy development.

## **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

Administration has reviewed the need for this policy and has determined that after the passing of the Procurement Policy C-2B.012 Amendment, Policy 2A.002 Expenditures not included in Budget Policy, is no longer relevant and proposes that Council rescind this policy. The Procurement Policy Amendment already covers the criteria that would be outlined in this policy, and therefore redundant legislation. Rescinding this policy will also remove the potential of conflicting policies.
