PROPOSAL & BACKGROUND

Administration is requesting a decision for first reading on Bylaw No. LU 575 in order to amend the Land Use Bylaw No. 1667.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Administration hereby presents to Council Bylaw No. LU 575, amending the Land Use Bylaw No. 1667. The proposed bylaw creates two new Direct Control Districts: Direct Control District #5 – Municipal District of Bonnyville Regional Airport – YBY, and Direct Control District #6 – Industrial Direct Control District – DCI.

Should first reading be carried, Administration will begin the referral process to landowners and the public to inform them of the proposed bylaw and gather any feedback or questions.
