Title: 2023 Community Funding Budget Redistribution Request

PROPOSAL & BACKGROUND

In the 2023 Operating Budget, Council allocated \$200,000 for two Community Funding programs established through policy: Policy 3C.012 the Community Action Grant (CAG) Policy and Policy 2A.003 Donation, Sponsorship, and Recognition Policy. Administration is requesting Council consider a redistribution of the funds between these two programs considering the proportion of community requests actually received to date.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

The Donation, Sponsorship, and Recognition Policy monetary budget of \$30,000 has been oversubscribed and fully funded as of the end of June 2023. There has been 45+ monetary requests awarded and currently seven requests pending at an estimated total of \$36,700.

To date, the CAG Program budget of \$170,000 has provided \$39,500 to local non-profit community groups events and projects with an additional \$31,400 pending requests received and being processed. This program has one application intake remaining (by October 15, 2023) for the Events/Programs Sponsorship or Small Capital Project Streams at a maximum value of \$5,000 per application.

Given the unlikelihood of the remaining available CAG budget to be fully utilized, Administration recommends Council considers transferring \$30,000 from the Community Action Grant Program 2023 budget to the Donation, Sponsorship, and Recognition Policy budget.
