#### **PROPOSAL & BACKGROUND**

M.D. Policy No 1.011 Property Tax Cancellation Policy "establishes a uniform and consistent approach for Council to address property tax penalty payment cancellation requests in the M.D." When Administration receives a property tax cancellation request for Council's consideration, the requests are placed in one of 2 categories.
