# PROPOSAL & BACKGROUND

Since last fall Council has approved a few amended and new Terms of Reference documents for various municipal and regional boards and committees. In response to these changes Administration has prepared an amending bylaw to replace the amended documents and add the new ones.

Council passed first reading for this Bylaw on September 12, 2023.

# **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

Bylaw No. 1856 makes amendments to Bylaw No. 1748 Boards and Committees Bylaw as well as Bylaw No. 1808 Amending Boards and Committees Bylaw. A brief summary of these amendments include:

- Deleting the reference to the Regional Economic Development Committee as well as the associated Terms of Reference (Council approved disbanding this Committee at the 2022 Organizational Meeting)
- Replacing Schedule "A" Committee of the Whole Terms of Reference (amended October 2022)
- Replacing Schedule "F" Rural Community Policing Committee Terms of Reference (amended July 2023)
- Adding reference to the Emergency Advisory Committee and attaching the associated Terms of Reference as Schedule "H" (adopted November 2022)
- Adding reference to the Regional Sports Tourism Committee and attaching the associated Terms of Reference as Schedule "I" (adopted by all Councils as of June 2023)

Administration is also seeking Council approval to consolidate the Boards and Committees Bylaw with all amendments into one document for ease of use by staff and the public.
