Title:	Adoption of Intermunicipal Trails Master Plan	

PROPOSAL & BACKGROUND

At the Regular meeting of Council on July 11th, 2023, Council requested the Intermunicipal Trails Master Plan presented by project consultant RC Strategies be brought forward for their further consideration and adoption.

The Intermunicipal Trails Master Plan project was a collaborative, grant funded effort of the M.D. of Bonnyville and the City of Cold Lake to guide improvements to the connectivity and quality of the region's trails and trail experiences for residents and visitors. These efforts were intended to function as a foundation and as a catalyst for the two municipalities to achieve their respective quality of life, community, environmental and economic goals as we move forward with the respective Councils during any future trail development discussions.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Benefits:

Successful trail destinations demonstrate that trails can be drivers of positive economic, social and environmental change, particularly for smaller rural communities. If carefully planned, developed, maintained and activated, trails can directly benefit residents and be a driver for tourism. The trail system that the M.D. has already invested in has made a very positive impact for our residents and outside users as proven by statistics from installed traffic counters recently presented to Council, showcasing the overall usage to date this year.

Disadvantages:

Trails can also pose some disadvantages such as engineering and construction expenses, and the operational maintenance costs necessary to attain the level of service expected by our residents.

Upon the adoption of this Plan:

- 1) That both municipalities agree to continue to collaborate through future meetings to discuss trail focus locations and establish trail development priorities.
- That both municipalities meet with the respective provincial government departments to access the recently approved grant funding allocated for trail development within the province of Alberta, specifically on Crown Lands.
