Title:	Policy No. 3A.015 Land Acquisition Policy – Amendment	

#### PROPOSAL & BACKGROUND

Administration is presenting Policy No. 3A.015 Land Acquisition Policy to be amended.

Due to the resistance encountered from landowners unwilling to sign agreements with the Municipal District of Bonnyville at the current prescribed rate for construction projects, a review of the Land Acquisition was completed.

#### **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

During this review, it was determined that increasing the compensation amounts may make it more palatable for landowners to sign land acquisition agreements with the municipality.

The proposed amendments to current Policy No. 3A.015 will increase the compensation payable to the landowner from \$2,000.00 per acre to \$2,500.00 per acre. As well, amendments propose to increase the minimum compensation from \$500.00 to \$1,000.00.

Proposed amendments to 2A.009 Municipal Lands Policy were presented to Committee of the Whole on September 19, 2023. The Committee of the Whole recommended to Council adopting the amended policy.
