Title:	Discontinuation of Recording Council Meetings

## PROPOSAL & BACKGROUND

Early in 2020 the Coronavirus pandemic caused the restriction of public functions and in particular of the public's ability to attend Council Meetings in the gallery and in person. The M.D. of Bonnyville moved to both live streaming Council Meetings digitally and to recording the meetings for airing on social media platforms.

As the pandemic has since abated and as the M.D. ceased live streaming Council Meetings some time ago, the last vestige of the pandemic in the M.D. operations is the continued recording of the meetings for airing on M.D. social media platforms. The proposal would be to cease those recordings.

## **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

The Covid-19 pandemic created an inability for all municipalities to continue public meetings. On April 1, 2020 the M.D. of Bonnyville moved to livestreaming and recording Council/Committee Meetings for later distribution in order to keep the public nature of Council Meetings and to meet the requirements of the special MGA legislation that was passed by the province to respond to the pandemic. Openness and transparency being paramount for good governance, the live streaming and recordings allowed the public to "be present" at Council meetings even though they were not allowed to be physically present. Once the pandemic had ceased, and on July 14, 2021 the M.D. of Bonnyville discontinued the live streaming and opened Council Chambers to public participation. The last remaining remnant of the impact of the Covid pandemic on our organization are the recorded meetings which are presented on social media. These recordings and downloaded videos do require significant staff time.

As Council Chambers are once again open to the public and as the recorded meetings are no longer required for pandemic purposes, and as the M.D. did not record or publish recordings of Council meetings prior to the pandemic, the Committee of the Whole is recommending to Council that recorded Council meetings cease immediately.
