PROPOSAL & BACKGROUND

Administration is requesting a decision for second and third reading on Bylaw No. LU 577 in order to amend the Land Use Bylaw No. 1667.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Administration hereby presents to Council Bylaw No. LU 577, amending the Land Use Bylaw No. 1667. The proposed Bylaw will amend Section 57 of the Land Use Bylaw by removing text that limits development and subdivision within proximity of Oil and Gas Facilities.

Bylaw No. LU 577 received first reading on October 24, 2023 and a Public Hearing was held on November 14, 2023.

Comments were received from TC Energy and Enbridge requesting amendments to be included which would provide additional maps and wording regarding requirements within proximity of oil and gas facilities. These comments and requested amendments can be seen under Appendix C.
