Title:	Bylaw No. 1858 Road Allowance Licensing Bylaw

PROPOSAL & BACKGROUND

Administration is seeking approval for Roadway License Bylaw No. 1858 authorizing the M.D. of Bonnyville to enter into an agreement to license a Roadway in accordance with Policy No. 3A.018 - Licensing of Roadways Policy.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Bylaw No. 1858 is a re-application of expired Road Allowance Lease Bylaw No. 1678, as per the legal description in Appendix A. The purpose of this Roadway License is to be utilized for access to IORL Nabiye Insitu Oil Sands Project.
