PROPOSAL & BACKGROUND

The Council Committee of the Whole conducted operating and capital budget deliberations on November 1, 2 & 3, 2023 and completed deliberations on November 21, 2023. During those sessions, Committee directed administration to make several adjustments, which have now been incorporated into 2 final budget documents attached as Appendix A: 2024 – 2026 Operating Budget and Appendix B: 2024 – 2028 Capital Plan

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Approval of an operating budget and a capital plan provides Administration with clear direction and the authority to conduct the business of, and provide services to, the municipality on behalf of Council.

Failure to approve an operating budget and a capital plan will result in a legislated requirement to approve an interim operating budget and may delay commencement of required work for the upcoming year.

The attached appendices reflect the Council Committee of the Whole direction to levy a 2.21% General Tax. This increase will result in an average residential tax increase of \$31.70 per year.
