Register today for the Canadian Apprenticeship Service and receive up to \$20,000 in grants for hiring and training first year-apprentices in 39 Red Seal construction and manufacturing trades.

In addition to financial incentives, resources and training are provided to assist with recruiting, onboarding, and retaining apprentices.

The Canadian Apprenticeship Service is administered in partnership with The Canadian Apprenticeship Forum, Aboriginal Apprenticeship Board, Canadian Construction Association, BuildForce, SkillPlan and Apprenticesearch.com.

Supporting skilled trades employers in our network with help in hiring and onboarding skilled trades talent and accessing grants, including the <u>Canadian Apprenticeship Service</u>.

The Canada Small Business Financing Program makes it easier for small businesses to get loans from financial institutions by sharing the risk with lenders. The maximum loan amount for a borrower is \$1.15 million.

- Up to a maximum of \$1,000,000 for term loans for any one borrower, of which no more than \$500,000 can be used for purchasing leasehold improvements or improving leased property and purchasing or improving new or used equipment and of that amount, a maximum of \$150,000 could be used for intangible assets and working capital costs.
- Up to a maximum of \$150,000 for lines of credit.
   Financial institutions deliver the program and are solely responsible for approving the loan. For more information download their PDF pamphlet or click here to find a lender near you.
