Title: Land Use Bylaw Review and Update Project – Request for Proposals Update

PROPOSAL & BACKGROUND

On October 18, 2023, Administration issued a Request for Proposals on the Alberta Purchasing Commission (APC) and on the municipal website soliciting the services of a planning consultant to complete a Review and Update to the M.D. of Bonnyville Land Use Bylaw (LUB). Three proposals for the project were received, evaluated, and ranked based on the identified project requirements and scoring matrix criteria. With the costs of the highest-ranking proponent slightly over the current project budget of \$50,000, Administration is requesting additional funding for this project in the amount of \$8,413.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

The Land Use Bylaw has remained in the same basic composition since 2000. A major update was completed in 2017, with minor changes completed since then in response to immerging issues like the legalization of marijuana and changes in development authority. This review and update will ensure that the LUB is consistent with the recently updated Municipal Development Plan, remove obstacles for the development process, and be user-friendly as per the direction in the 2022-2027 Council Strategic Plan.

Public awareness of municipal Land Use Bylaws in general has increased. This has changed the project from less of an internal review to a more involved external stakeholder education and engagement process. It is a benefit to have the public more engaged in the process, but it also increases project work and costs.

The proposals received in response to the RFP were reviewed and scored on a number of criteria such as: experience, innovation, approach and methodology, similar projects completed, schedule, stakeholder engagement, and fees.

The highest-ranking proponent is the most experienced, has completed other Land Use Bylaw review projects, and has completed numerous stakeholder engagements for municipal planning and development projects.
