Title: Bylaw No. LU 578 Amending LUB Bylaw

PROPOSAL & BACKGROUND

Administration is requesting a decision for second and third reading on Bylaw No. LU 578 in order to amend the Land Use Bylaw No. 1667 for the rezoning of NW-30- 61-5-W4M and NE-30-61-5-W4M from Agriculture (AG) District to Direct Control District #5 – Municipal District of Bonnyville Regional Airport (YBY).

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Bylaw No. LU 578, rezoning application, was presented to Council and given first reading at the January 9, 2024, Regular Meeting of Council, and a Public Hearing was held on February 13, 2024.

The current area of NW-30-61-5-W4M is approximately 47.58 acres (19.237 ha). The current area of NE-30-61-5-W4M is approximately 30.1 acres (12.119 ha). The subject parcels are proposed to be rezoned from Agriculture (AG) District to Direct Control District #5 – Municipal District of Bonnyville Regional Airport (YBY).

No concerns were received during the public notifications process and no members of the public were present at the Public Hearing held on February 13, 2024.
