Title: 2024 Waste Services State of the Infrastructure Report

PROPOSAL & BACKGROUND

Administration has drafted a report and presentation on the "2024 Waste Services State of the Infrastructure Report" to summarize for Council the assets located at the 6 landfill transfer stations and 54 rural bin sites.

This State of the Infrastructure Report describes the asset inventory, value, life, condition, and the investment needed to maintain the current levels of service for the Waste Services Department. This is a snapshot of waste services engineered assets (structures) as of December 31, 2023. The Report includes a wide variety of engineered assets that are essential to providing services, such as the landfill transfer stations and rural bin sites to support services the M.D. provides.

The engineered assets are kept in good or very good condition by repairing, constructing, and replacing them to maintain current service levels. Through formal and informal assessments, assets receive regular maintenance and do not fall into the poor or very poor category.

The report also includes "Fleet, Machinery and Equipment" operated, and maintained by the Waste Services department to provide services to the M.D. residents. The replacement costs for these items are budgeted through the Equipment Replacement Program (ERP).

This report provides a basis for recommendations for future long-term financial planning and financial strategies for engineered assets and does not include any recommendations for "Fleet, Machinery, and Equipment".
