Title: M.D. Airport Terminal Construction – Update

PROPOSAL & BACKGROUND

Infrastructure Services released a Request for Proposal (RFP) for a design build of the M.D. Airport Terminal Building.

All four (4) proposals were significantly over the approved budget for the construction and Administration subsequently cancelled the tender on Alberta Purchasing Connection (APC).

Average price from submitted tenders was \$1,768,150.00.

Handouts provided to Council contain information relating to the RFP and submissions.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

As the submissions were all over budget, Administration explored alternative options:

- 1. Self-performing the construction After review of the material and contractor costs, this option had no cost saving opportunities.
- 2. Renovating the existing terminal building with an addition Considering the age and style of the existing building and that asbestos containing materials were used in the building construction, this was deemed to not be a feasible option.

Administration attempted to solicit outside funding for the construction from industry partners, however, no additional funding was committed.

Administration is offering additional options for Council:

- 1. Leave terminal building as is and cancel project.
- 2. Re-submit the design build RFP and increase budget for construction in 2024.
