Title: Bylaw No. 1866 Roadway Licensing Bylaw

PROPOSAL & BACKGROUND

Administration is seeking approval for Roadway Licensing Bylaw No. 1866 authorizing the M.D. of Bonnyville to enter into an agreement to license a Roadway in accordance with Policy No. 3A.018 - Licensing of Roadways Policy.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Bylaw No. 1866 is a new Roadway Licensing Bylaw, as per the legal description in Appendix A. The purpose of this Roadway License is to be utilized for extra grazing land for cattle.

A copy of the Roadway License Agreement Application was provided to Infrastructure Services and Environmental & Protective Services for review and recommendation; there were no concerns.
