One of the things the Bonnyville RCMP promoted for MV theft was Operation Cold Start (where Bonnyville Detachment was recognized for having the most contacts with vehicle owners/drivers than any other Detachment in K DIV). We also enlisted Auto Theft's assistance and made use of the Bait Truck a couple of times this fiscal year. It was successful in charging 3 known offenders with theft of the truck. Theft of MVs will continue to be monitored on next fiscal year's APP.
