Title: Bylaw No.579 Amending LUB Bylaw

PROPOSAL & BACKGROUND

Administration hereby presents to Council an amending LUB Bylaw to achieve the rezoning of Plan 862 0814 Lot 1(Pt. SE-16-62-1-W4M) from Hamlet Single Family Residential District – HR1 to Hamlet General District – HG. This would allow the Latter-Day Saints Church Meeting Hall, which was perished by fire in 2023 as is currently approved to be rebuilt, as a permitted use under the Hamlet General District – HG.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

The M.D. of Bonnyville Administration is proposing the rezoning of the subject parcel based on a submitted application. The current area for Plan 862 0814 Lot 1(Pt. SE-16-62-1-W4M) is approximately 4.99 acres (2.02 hectares). The subject parcel is proposed to be rezoned from Hamlet Single Family Residential District – HR1 to Hamlet General District – HG.

If Council approves first reading of the Bylaw today, the Public Hearing for Bylaw No. LU579 will be scheduled for June 11, 2024.


