#### **PROPOSAL & BACKGROUND**

The Municipal District of Bonnyville identified the need to upgrade its economic development presence on line during the completion of the 2020 Regional Economic Development Plan. As well, a stand-alone economic development website was recognized as an action item in the adopted 2022 M.D. Business and Industry Growth Strategy and subsequently added to the department's 2024 Business Plan.

Administration has now completed the website redevelopment in conjunction with our current website provider CivicPlus, and is happy to present it to Council today for information.

#### **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

The new economic development website is complete with its own domain <u>investmdbonnyville.com</u>. This website provides enhanced visibility for economic development as a business unit of the M.D. dedicated to investment attraction.

The new economic development website hosts a Community Economic Development Dashboard. The dashboard provides crucial one stop information such as demographic, labour force, taxation, quality of life, real estate, transportation, utilities and business environment data crucial for site selectors and developers.

It also supports investment attraction through the provision of industry specific profiles that highlight the strength of existing sectors such as energy as well as targeted sectors such as protein and agriculture technology.
