Title: Bylaw No. 1861 Amending Municipal Development Plan Bylaw

PROPOSAL & BACKGROUND

Bylaw No. 1853 for the Municipal Development Plan (MDP) of The Municipal District of Bonnyville No. 87 received third reading by Council on October 24, 2023. A review of this bylaw revealed an error pursuant to s.692(6) of the *Municipal Government Act*. The proposed amendments are to correct that error.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

The MDP is a long-term planning document, setting direction for 10 or more years into the future, that Council uses to make decisions about the community. The MDP is referenced often and is an important guiding tool for community development and to help deal with the constant change, evolution, growth, and decline of communities.

The amendment presented is to correct a document reference in section 5.2 (1.) of a "Bylaw 20-2017", which is does not exist. We will amend it to reference the previous Municipal Development Plan Bylaw No. 1367 as shown in Appendix A.

To make the necessary correction, an amending bylaw must receive three readings; additionally this amendment does not materially affect the bylaw in principle or substance and may be amended without giving notice or holding a public hearing.
