Title: Iron River School Association – Playground Project Update

PROPOSAL & BACKGROUND

In 2021 and 2022, the M.D. of Bonnyville donated a total of \$262,000 towards a new playground project for the Iron River School Association. The project was successfully completed in 2023 below budget due to unexpected discounts from vendors as well as some work being able to be completed in-house (which initially was not an option). In light of these savings, the Association has submitted a request to Council to confirm their approval of using the remaining funds for some additional features near the playground.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

With the remainder of the funds being \$47,855.82, the Iron River School Association would like to propose a Phase 2 addition to the project. No further funding is being requested.

Their first-choice option is to enhance the outdoor play area by building a pavilion to act as an outdoor learning area. Their second-choice option would be adding an additional piece of play equipment to the playground. As this new Phase 2 project is out of scope of the original proposal, they are seeking approval from Council to proceed.
