Title: Bylaw No. 1866 Roadway Licensing Bylaw

PROPOSAL & BACKGROUND

Administration is requesting a decision for second and third reading for Roadway License Bylaw No. 1866 which would authorize the M.D. to enter into an agreement to license a roadway in accordance with Policy No. 3A.018 - Licensing of Roadways Policy.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Bylaw No. 1866 for Road Allowance Licensing was presented to Council and given first reading at the May 14, 2024, Regular Meeting of Council.

Notification of the proposed Road Allowance Licensing was mailed to utility companies, potentially affected stakeholders and adjacent landowners, with a deadline of June 14, 2024, to submit concerns to be considered when the Bylaw is brought forth for second and third readings.

No correspondence or communication of concerns has been received regarding this application.

As per Policy No. 3A.018, the feasibility of granting the temporary roadway license is subject to:

- 1. The number of properties and property owners that may be impacted. ANSWER: Adjacent to the proposed licensing area, there is one (1) Provincial Lease and five (5) titled parcels of land. "Adjacent" means land that is contiguous to the parcel of land that is being licensed and includes land that would be contiguous if not for a highway, road, river, or stream. Of the adjacent lands, one (1) parcel of land is owned by the applicant;
- 2. Whether there is agreement among the adjacent landowners. ANSWER: no correspondence was submitted from adjacent landowners; and
- 3. The reason for the proposed license. ANSWER: as per the April 15, 2024, application, the purpose/reason of this application is to be utilized for extra grazing land for cattle.
