TC Energy periodically provides stakeholders, landowners, and Indigenous groups information at the early stages of project development to keep them informed of our potential activities and developments. As such, NGTL GP Ltd. (NGTL GP), as general partner on behalf of NGTL Limited Partnership, an affiliate of TC Energy, is beginning to investigate options for a potential NGTL System expansion in NGTL GP's Wood Buffalo Area with a focus on development north of Bonnyville, in the M.D. of Bonnyville No. 87.

An option being considered is a natural gas pipeline loop section called the Sand Section, which would be approximately 20 km of 20-inch pipeline located approximately 45 km northwest of Bonnyville, AB. A pipeline loop section is the installation of a new pipeline adjacent to an existing pipeline that allows for both lines to be operated in parallel to increase the capacity of the system.

This option would address possible additional flow requirements based on interest expressed by NGTL GP customers for new and incremental NGTL System service. At this time, NGTL GP is in the preliminary stages of development which is subject to and dependent on commercial support.

If NGTL GP determines this option is required, and subject to a final investment decision to proceed, NGTL GP would file a Section 214 application with the Canada Energy Regulator as early as Q1 2025. In the coming months, we will contact potentially affected Indigenous groups, stakeholders and landowners to discuss the potential facilities, routing, survey work, environmental studies and early land access requirements.
