BYLAW NO. 1867

BEING A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF CLOSING FOR PUBLIC TRAVEL AND SELLING A PORTION OF GOVERNMENT ROAD ALLOWANCE.

WHEREAS, under the provisions of the Municipal Government Act, R.S.A 2000, Chapter M-26, and amendments thereto, no road in a municipality that is subject to the direction, control and management of the municipality may be closed except by bylaw;

AND WHEREAS, under the provisions of the Municipal Government Act, R.S.A 2000, Chapter M-26, and amendments thereto, a bylaw closing a road made by the council of a municipality that is not a city has no effect unless it is approved by the Minister of Transportation before receiving second reading;

AND WHEREAS, the lands hereinafter described are no longer required for public travel;

AND WHEREAS, application has been made to Council to have the government road allowance closed and sold;

AND WHEREAS notice of intention of the Council to pass a Bylaw has been given in accordance with the Municipal Government Act, R.S.A 2000, Chapter M-26, and amendments thereto; and

AND WHEREAS Council was not petitioned for an opportunity to be heard by any person prejudicially affected by the bylaw;

NOW THEREFORE, the Council of the Municipal District of Bonnyville No. 87, duly assembled in the Province of Alberta, hereby enacts the following:

1 ROAD CLOSURE AND SALE

- 1.1 That the portion of road as described below is hereby closed to public traffic subject to the rights of access granted by other legislation.

Meridian 4 Range 3 Township 60

All that portion of Government Road Allowance adjoining SW 33 which lies within plan 242 _____

Excepting thereout all mines and minerals.

2 EFFECTIVE DATE

- 2.1 That this Bylaw shall come into force and have effect from and after the date of third and final reading thereof.

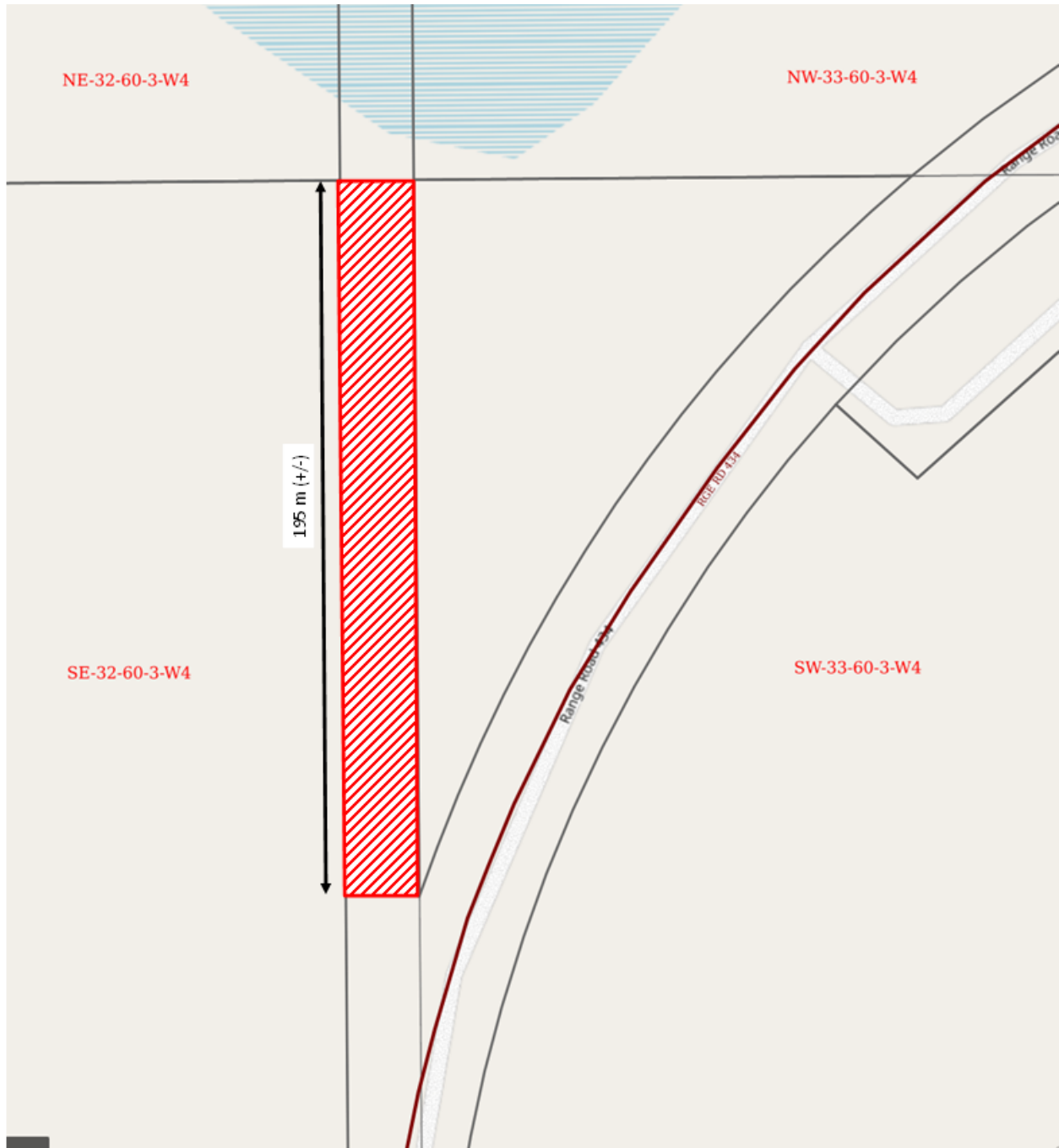
