Title: M.D. Seniors Transportation Grant Program

PROPOSAL & BACKGROUND

In past years the M.D. Seniors Transportation Grant Program has been managed by the Bonnyville and District FCSS with funding provided by the municipality. Administration is proposing that this grant program be managed in-house effective immediately. Attached is an updated draft of Policy No. C-1.005 Seniors Transportation Grant Policy with revisions to reflect the MD's management of the program for Council's consideration.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Over the years, M.D. Council has allocated a portion of money towards a program to assist seniors in attending medical related appointments and procedures outside of the M.D. boundaries. In 2024 the M.D. Council has allocated \$50,000 towards the Seniors Transportation Grant.

In the past this grant was managed by the Bonnyville and District FCSS and payments were made to the applicants through the FCSS. Recently there have been changes at the Bonnyville and District FCSS and Administration believes the program may be better served through in-house management. Managing this program in-house will lessen the "red tape" for applicants by allowing M.D. staff to directly provide the service, and Council will have direct access to policy and governance control of the allocated funds.
