## PROPOSAL & BACKGROUND

Administration is requesting a decision for second and third reading on Bylaw No. LU 579 in order to amend the Land Use Bylaw No. 1667 for the re-zoning of Lot 1; Block 1; Plan 862 0814 (Pt. SE 16-62-1 W4M) within the Hamlet of Cherry Grove from Hamlet Single Family Residential District – HR1 to Hamlet General District (HG).

## **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

Bylaw No. LU 579, rezoning application, was presented to Council and given first reading at the May 14, 2024, Regular Meeting of Council, and a Public Hearing was held on July 9, 2024.

The current area of Lot 1; Block 1; Plan 862 0814 is approximately 4.99 acres (2.02 hectares). The subject parcel is to be rezoned from Hamlet Single Family Residential District – HR1 to Hamlet General District (HG).

No concerns were received during the public notification process and no members of the public were present at the Public Hearing held on July 9, 2024.
