### **PROPOSAL & BACKGROUND**

Administration is seeking approval for Bylaw No. 1879, Amending Municipal Land and Reserves Bylaw, authorizing the M.D. of Bonnyville to amend the regulation of activities on Municipal Land in the existing Municipal Land and Reserves Bylaw No. 1766.

### **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

The reason for the proposed amendment is to address a gap identified during a recent review of the existing bylaw, which currently does not include any specific regulations regarding the consumption of alcohol or cannabis on Municipal Land.

Bylaw No. 1879 makes amendments to Bylaw No. 1766 Municipal Land and Reserves Bylaw. A brief summary of the amendment includes:

- Adding the regulation of consumption of liquor or cannabis within Municipal Land in accordance with the *Alberta Gaming, Liquor and Cannabis Act*.
