PROPOSAL & BACKGROUND

In September Council passed new bylaws establishing a Joint Assessment Review Board and Intermunicipal Subdivision and Development Appeal Board. In response to this change, Administration has prepared a bylaw to make necessary amendments to Bylaw No. 1748 Boards and Committees Bylaw.
