Title: 2024 Community Association Operating Grant Program Report

#### PROPOSAL & BACKGROUND

Administration has completed the comprehensive review of all submitted 2024 Community Association Operating Grant applications and has finalized the evaluation results for Council review and approval. The results were determined based on the submitted documentation and the program criteria identified in the associated Policy (see Appendix A).

### **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

The highlights from this year's review are:

- 24 applications were received out of a possible 28 qualifying organizations.
- All submissions met the program requirements; however, some were reduced based on a smaller demonstrated financial need. If all were awarded, the total award would be \$608,400.
- The 2025 Community Association Operating Grant budget is \$500,000.

Based on the program's first come, first serve requirement, Administration has attached the evaluation results by the date all mandatory application documentation was submitted by the applicant and received by the M.D of Bonnyville.
