Title:	Winter Road Maintenance Swap with EMCON Services Inc.	

PROPOSAL

Administration has had a discussion with EMCON Services Inc. regarding winter maintenance on 2 sections of road within the M.D. boundary.

It is proposed that approximately 2 miles of TWP Rd 610 (APPENDIX A), maintained by EMCON be swapped with approximately 2 miles of RGE Rd 450 (APPENDIX B), maintained by the M.D.

DISCUSSION

TWP Rd 450 is a portion of road that is not connected to any route that is frequently maintained by Infrastructure Services. This section is in between sections of road maintained by EMCON (north) and the County of St. Paul (south). The M.D. has to high blade the plow truck to this section and then high blade back to the normal route. This can take an estimated 1.5 hours for a return trip for a 2-mile section.

TWP Rd 610 is on the way for the plow trucks to plow the coldmix road south of Bonnyville Beach. The M.D. could easily maintain this section of road on the way to the coldmix. The M.D. receives many calls from ratepayers about this road, and can offer no solution to their concerns other than to direct them to EMCON.

If maintenance of these sections of road were transferred, this would allow for more efficient plowing operations in the M.D..
