# **APPENDIX A**

## **BYLAW NO. 1885**

BEING A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF GRANTING A LICENSE OR PERMIT FOR THE TEMPORARY OCCUPATION OR USE OF A ROAD ALLOWANCE.

**WHEREAS**, Section 13(1)(o) of the Traffic Safety Act, Chapter T-6, RSA 2000, as amended, grants the authority to a Council to pass a bylaw granting a license or a permit for the temporary occupation or use of a road allowance when it is not required for public use, if such license or permit is terminable on 30 days' notice;

**WHEREAS**, the land hereafter described is no longer required for public travel;

**WHEREAS**, an application has been made to the Council for the temporary use and occupation of the said lands;

**AND WHEREAS**, notice of the intention of Council to pass a bylaw has been published in accordance with the Municipal District of Bonnyville No. 87 Public Notification Bylaw prior to the final passing thereof; and

**NOW THEREFORE**, Council of the Municipal District of Bonnyville No. 87, duly assembled in the Province of Alberta, enacts as follows:

- 1. That Council of the Municipal District of Bonnyville No. 87 does hereby grant a license for the temporary occupation or use of the following roadway:
  - 1.1. All that portion of government road allowance at the east end of Spruce Ave located in Evergreen Estates (SW 19- 61- 6-W4M) described as follows: commencing at the northeast corner of Spruce Ave abutting Lot 13, Block 5, Plan 862 1217 for a distance of 28 meters (92 feet) westerly along the north boundary; thence southerly along the west boundary for a distance of 34 meters (111 feet); thence diagonally along the southeast boundary abutting Lot 13, Block 5, Plan 862 1217 to the point of commencement for a distance of 42 meters (138 feet) within SW 19- 61- 6- W4M, reserving unto His Majesty all mines and minerals.
- 2. That the license be granted for an initial term of 3 years, which may be renewed at the discretion of Administration, and that it may be terminated on 30 days' notice in writing.
- 3. That no erection of any building, structure or other permanent improvement except for a fence be permitted.
- 4. That the license be issued subject to rights of access granted by other provincial and municipal legislation or regulations.
- 5. That such license be issued to Darcy and Arlene Vasseur, Box 5602, Bonnyville, Alberta, T9N 2G6.
- 6. That this license be granted as of the date the associated Roadway License Agreement is made effective, until the termination or withdrawal of the associated Roadway License Agreement.
- 7. That this Bylaw shall come into force and have effect from and after the date of the third and final reading thereof.
