BYLAW NO. 1888

BEING A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF GRANTING A LICENSE OR PERMIT FOR THE TEMPORARY OCCUPATION OR USE OF A ROAD ALLOWANCE.

WHEREAS, Section 13(1)(o) of the Traffic Safety Act, Chapter T-6, RSA 2000, as amended, grants the authority to a Council to pass a bylaw granting a license or a permit for the temporary occupation or use of a road allowance when it is not required for public use, if such license or permit is terminable on 30 days' notice;

WHEREAS, the land hereafter described is no longer required for public travel;

WHEREAS, an application has been made to the Council for the temporary use and occupation of the said lands;

AND WHEREAS, a notice of the intention of Council to pass a bylaw has been published in accordance with the Municipal District of Bonnyville No. 87 Public Notification Bylaw prior to the final passing thereof; and

NOW THEREFORE, Council of the Municipal District of Bonnyville No. 87, duly assembled in the Province of Alberta, enacts as follows:

- 1. That Council of the Municipal District of Bonnyville No. 87 does hereby grant a license for the temporary occupation or use of the following roadway:
 - 1.1. The southerly 775 meters of Government Road Allowance adjacent to the East Boundary of NE 34-63-7-W4M; Rge Rd 472, reserving unto His Majesty all mines and minerals.
- 2. That the license be granted for an initial term of 3 years, which may be renewed at the discretion of Administration, and that it may be terminated on 30 days' notice in writing.
- 3. That no erection of any building, structure or other permanent improvement except for a fence be permitted.
- 4. That the license be issued subject to rights of access granted by other provincial and municipal legislation or regulations.
- 5. That such license be issued to Shaun Blize and Steven Kardash, both of: General Delivery, Iron River, Alberta, T0A 2A0.
- 6. That this license be granted as of the date the associated Roadway License Agreement is made effective, until the termination or withdrawal of the associated Roadway License Agreement.
- 7. That this Bylaw shall come into force and have effect from and after the date of the third and final reading thereof.


