Rat Control Program

We have completed 1061 site visits as per our agreement with Alberta Agriculture and Irrigation. During those inspections 403 bags of Warfarin, 48 bags of Ramex, and 12 blocks of Contrac were distributed to residents. Rat bait dispensed was substantially lower due to changes in the procedures. One rat call was investigated near Cherry Grove. The resident was dealing with mice.

Subdivision/Hamlets Mowing


Program Start: June 6









The Agricultural Service Board Grant (ASB) assist municipalities with fulfilling their requirements under the *Agricultural Service Board Act.* A new grant application for 2025 - 2029 was completed and submitted for the M.D. of Bonnyville's ASB.

The Agriculture Services Department has settled into their new location and operations are running smoothly.

Bonnyville Seed Cleaning Plant

The yearly seed plant inspection was completed on November 21st. The Bonnyville Seed Plant passed with a score of 96.89%. The seed pant has made considerable improvements from last years inspection. We continue to encourage producers to clean and test their seed yearly. This lowers the establishment of noxious weeds, pests, and diseases.

Shelterbelt Program

Seedlings for the 2025 shelterbelt program have been ordered. Trees go on sale on March 11, 2025.

Little Bear Aeration Project

The aerators were installed at Little Bear Lake at the beginning of October. The snow fence was installed in December, during that time, Alberta Conservation Association replaced an aerator that stopped working.
