PROPOSAL & BACKGROUND

Administration is bringing forward Policy No. C-1.010 to update the monthly salary honorarium for members of Council to 2025 rates as well as add clarity around the annual cost of living adjustments.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

The monthly salary honorarium for members of Council in Policy No. C-1.010 has not been updated since 2022. Administration is proposing to update the policy to reflect the 2025 rates. Since 2022, elected official honorariums have been increased annually in conjunction with cost of living adjustments approved by Council through the annual budget approvals.

To enhance transparency and clarity, Administration is proposing to update the policy to reflect the 2025 rates as well as add verbiage clarifying how Council's cost of living adjustment is approved annually.

Additionally, Administration is proposing to adjust the review timeline for the document to be annually to ensure monthly honorariums for members of Council are updated in policy following the adoption of the budget and have included an amendment to increase the maximum amount reimbursed for internet services to \$120 as recommended by the Committee of the Whole.

The Committee of the Whole reviewed this amending policy on February 18, 2025 and passed a motion recommending that Council adopt the amending policy as presented with the additional amendment to Section 4(a), increasing the maximum monthly reimbursement amount for internet services as mentioned above.
