Title: Bylaw No. 1893 Chief Administrative Officer Bylaw

#### **PROPOSAL & BACKGROUND**

Every municipality must establish, by bylaw, a position of Chief Administrative Officer (CAO) as per the Municipal Government Act (the Act). Additionally, as per the Act Council may also, through bylaw, delegate any of its powers, duties or functions.

There is currently a CAO Bylaw in place for the M.D. which establishes the CAO position as well as delegates some authority however Administration has prepared a new CAO Bylaw to remove some redundant content as well as update some of the authority delegated to the CAO to improve clarity as well as the ease and continuity of municipal operations.

# **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

Some of the primary changes within the new Bylaw No. 1893 CAO Bylaw include:

- Removing any reference to powers, duties and functions that are already under the responsibility of the CAO as per the Act to eliminate redundancy as well as avoid potential conflict with amendments to the Act in the future.
- Adding the authority to appoint a Designated Officer(s) as a municipal assessor under the Act. This was previously addressed in Bylaw No. 1212, Administration is proposing to amalgamate the content directly into the CAO Bylaw.
- Removing the delegation of the CAO as the Clerk for the Assessment Review Boards.
- Adding delegation of authority to the CAO for consolidating M.D. Bylaws.
- Designating the CAO as a Designated Officer to act as the lone signatory on municipal documentation within the approved Budget, unless otherwise required through the Act or any other statute.
- Addition of multiple provisions for added clarity and transparency including Council's appointment of an Interim CAO, a CAO Code of Conduct, and CAO evaluations.

The Committee of the Whole reviewed this new bylaw on February 18, 2025, and this bylaw received first reading at the Regular Meeting of Council on March 11, 2025.
