Title: Bonnyville and District Centennial Centre – Request for Additional Funding

PROPOSAL & BACKGROUND

The Bonnyville and District Leisure Facility Corporation passed the motion for option C with the addition of a Reverse Osmosis System with additional monies to come from C2 Municipal Reserves requiring an additional \$212K, \$106 K from Twon C2 Capital Reserves and \$106K from M.D. C2 Capital Reserve, based on approval of Town Council and M.D. Council.

Secondly, Administration is in receipt of the following information from the Bonnyville and District Centennial Centre: 2024 year-end for the Bonnyville and District Centennial Centre has been completed, subject to the auditor's report. Overall operating deficit and allocations are:

Overall Deficit: \$87,988.62
Outstanding from Town of Bonnyville (47.95%) \$42,190.54
Outstanding from MD of Bonnyville (52.05%) \$45,798.08

And that the deficit should be funded from the C2 Operating Reserve

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Schedule of Reserves held by the municipality for operation and capital are:

Reserve – Recreation (C2) – Operations \$54,388 Reserve – C2 Capital \$215,246

Should Council approve of the additional funding request made by the Bonnyville and District Leisure Facility Corporation, both operations and capital reserves will be depleted.

Administration has learned, in speaking with the General Manager, Bonnyville and District Centennial Centre, that the Operational deficit was the result of unexpected expenditures and could not have been anticipated at the time of approval of the 2024 Operational Budget.

Respecting the 2025 capital deficits. Administration has learned that the Reverse Osmosis System is anticipated to reduce energy costs at the facility.
