## BYLAW NO. 1780

BEING A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF GRANTING A LICENSE OR PERMIT FOR THE TEMPORARY OCCUPATION OR USE OF A ROAD ALLOWANCE IN ACCORDANCE WITH SECTION 13 OF THE TRAFFIC SAFETY ACT, CHAPTER T-6, REVISED STATUTES OF ALBERTA 2000, AS AMENDED.

**WHEREAS**, Section 13(1)(o) of the Traffic Safety Act, Chapter T-6, RSA 2000, as amended, grants the authority to a Council to pass a bylaw granting a license or a permit for the temporary occupation or use of a road allowance when it is not required for public use, if such license or permit is terminable on 30 days' notice;

**WHEREAS**, the land hereafter described is no longer required for public travel;

**WHEREAS**, application has been made to the Council for the temporary use and occupation of the said lands; and

**NOW THEREFORE**, Council of the Municipal District of Bonnyville No. 87 in the Province of Alberta, duly assembled, enacts as follows:

1. That Council of the Municipal District of Bonnyville No. 87 does hereby grant a license for the temporary occupation or use of the following road allowance:
  - 1.1. All that portion of Government Road Allowance East of NE 25-63-5-W4M and SE 25-63-5-W4M reserving unto Her Majesty all Mines and Minerals.
2. That the license be for a term not exceeding 3 years and that it may be terminated on 30 days' notice in writing.
3. That no erection of any building, structure or other permanent improvement except for a fence be permitted.
4. That the license be issued subject to rights of access granted by other provincial and municipal legislation or regulations.
5. That such license be issued to Ronald Brawn, Box 1794, Bonnyville, AB T9N 1P4.
6. That this license be granted as of January 1, 2022 until the termination or withdrawal of the associated Road License Agreement.
7. That this Bylaw shall come into force and have effect from and after the date of third and final reading thereof.

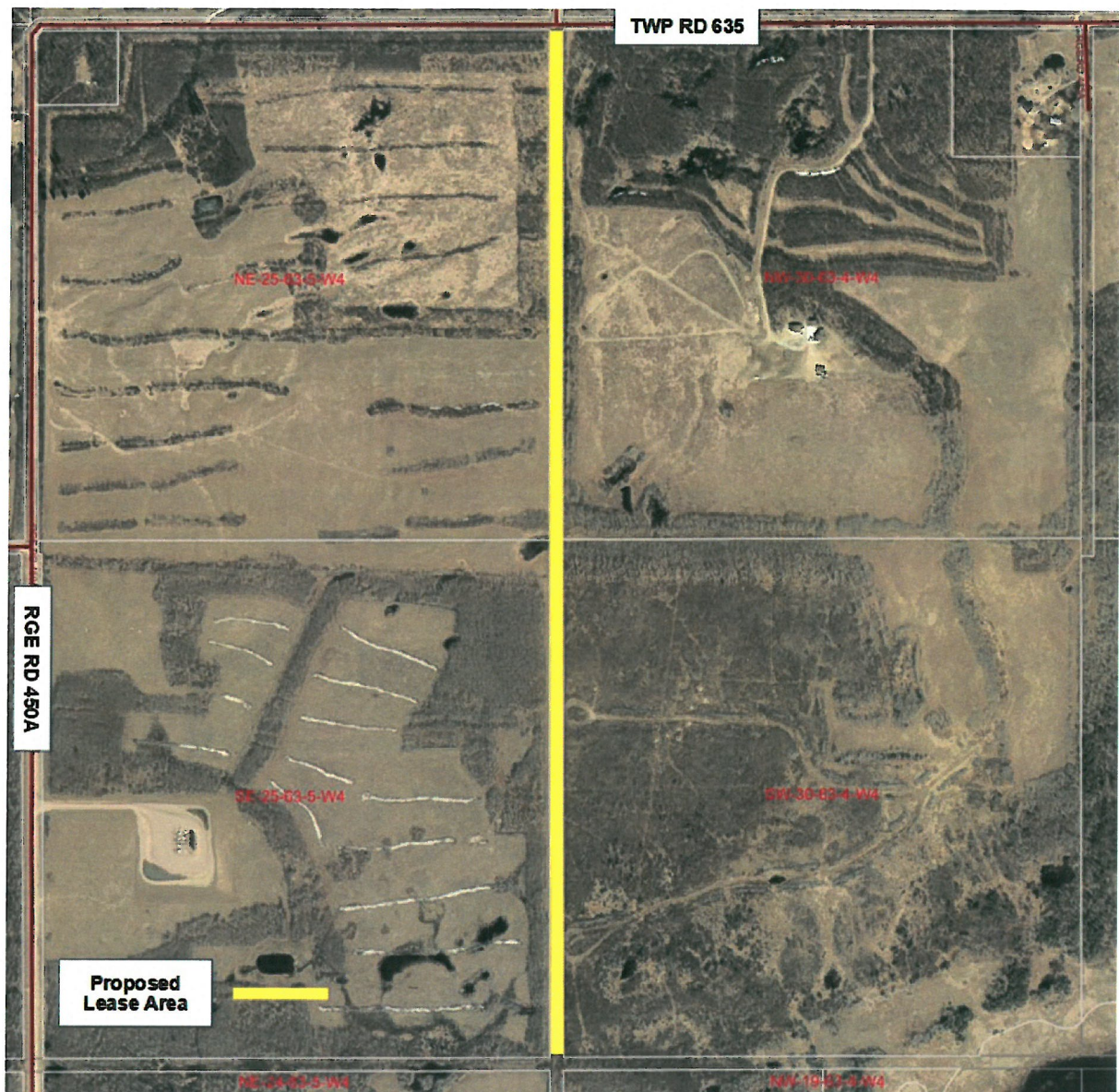
