PROPOSAL & BACKGROUND

The Alberta Bilingual Municipalities Association (ABMA) recently reached out to the M.D. of Bonnyville with a proposal to implement annual membership fees and have requested feedback from participating municipalities.

The M.D. has been a member of the ABMA since 2020 and has 1 representative position on the Board, with the current appointment being Deputy Reeve Skarsen and Reeve Kalinski (*alternate*) for a 4-year term expiring October 2025.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

The Alberta Bilingual Municipalities Association (ABMA) decided at their February 15, 2025 Association meeting, to present a proposal of introducing annual membership fees, believing that this will reflect a strong commitment from its members and act as a significant measure of involvement in the grant application process. These fees will expand ABMA initiatives, providing more resources for members.

The ABMA network brings together municipalities where Francophones contribute significantly to sustainable economic development. The Association aims to encourage strategic projects and initiatives of an economic nature that are beneficial to all represented regions and advocate for economically vibrant, sustainable, bilingual communities through a collaborative network of municipalities.

The annual membership fees proposed by the ABMA are included in the letter attached as Appendix A. The annual fee that would be applicable to the M.D. is the 'Municipal Districts/Counties' fee which is \$1,100.
