Title: Bylaw No. 1896 Revising CAO Bylaw

PROPOSAL & BACKGROUND

In March Council passed a new bylaw establishing the position of Chief Administrative Officer of the municipality. A technical administrative error was found in the bylaw during the processing of the document following third reading, and in response to this error, Administration has prepared a bylaw making the necessary revisions to Bylaw No. 1893 Chief Administrative Officer Bylaw.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Section 63 of the Alberta Municipal Government Act allows a municipality, by bylaw, to revise any of its bylaws, under specific criteria, including to "make changes, without materially affecting the bylaw in principle or substance, (i) to correct clerical, technical, grammatical or typographical errors in a bylaw,"

Following third reading of Bylaw No. 1893, Administration noticed that the incorrect Bylaw No. is referenced under Section 10 Repeal. Under subsections 10.1 and 10.2, where is says "Bylaw No. 1850", it should say "Bylaw No. 1893".

Administration has prepared and is presenting a revising bylaw to address these corrections.
