PROPOSAL

Administration has prepared a new policy to establish consistent standards and guidelines for the management of reserve funds for Council's approval.

DISCUSSION

The Municipal District of Bonnyville (M.D.) recognizes the need for prudent business practices that will enhance the M.D.'s long-term financial strength.
