### **PROPOSAL**

Administration is proposing a policy to establish guidelines for addressing requests from the public to name municipal roads, trails and facilities which maintain and promote community identity through the commemoration of noteworthy persons and/or organizations associated with the M.D., recognition of the M.D.'s heritage, and acknowledgment of the flora, fauna, and natural features of the community.

### **DISCUSSION**

This policy was created to coincide with Council's direction at the January 28, 2025 Council meeting.

This Policy provides guidelines for Administration to evaluate and consider public requests to name municipal roads, trails, and facilities with the aim of preserving community identity through the commemoration of notable individuals and organizations, recognition of local heritage, and acknowledgment of natural features.
